



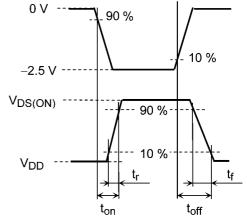


Fig. 5.3.1 Test Circuit of Switching Time
